Winter school on ICH and education - Ankara, Turkyie

UNESCO Chair on Intangible Cultural Heritage in Formal and Informal Education (Turkiye, Ankara Hacı Bayram Veli University) will organize a 6th Winter School on ICH on February 1-5, 2023. It will be organized in cooperation with the Ministry of National Education and the Turkish National Commission for UNESCO. This year's theme is ICH and education. The UNESCO ASPnet school coordinators from all around Türkiye will participate in the meeting, during which workshops and some hands-on activities will be conducted with the aim of introducing the teachers to the integration of ICH into various school subjects.

The UNESCO World Conference on Cultural Policies and Sustainable Development - MONDIACULT - Mexico City, Mexico

From 28 to 30 September 2022, 150 states and numerous cultural actors from civil society gathered in Mexico City for the UNESCO World Conference on Culture MONDIACULT 2022. Among other things, they discussed the vulnerability of the cultural sector and necessary countermeasures as well as the improvement of cultural statistics. The conference is a milestone in cultural policy. During the conference, the participating states adopt a historic declaration for culture. In particular, they call for the recognition of culture as a "global public good," meaning that culture is ensured and supported as the basis of life for all.

In view of the current profound crises, conflicts and transformations, the states recommit themselves to a fair arts and culture sector. The final declaration underlines the common responsibility: cultural policy must guarantee that culture can unfold its full potential for the sustainable development of society. Among other things, the states call for a reliable strengthening of cultural funding and an intensification of the dialogue on the restitution of cultural assets. Culture is emphatically affirmed as a human right in the final declaration.

The project involves nine countries led by the Finnish Heritage Agency and concentrates on recognising the practical ways how living heritage can support sustainable development and how living heritage could be developed and used in sustainable ways in e.g. tourism, education and several other practices. The project runs in 2021-2024 and comprises a range of activities – workshops, webinars, pilot projects, etc. The videos of several LIVIND webinars are online and more online events are coming up. The Interreg Aurora-funded Project "ICH North – Passing on Our Musical Heritage" will enhance the role of ICH in the form of musical heritage in the North. ICH North will give musical heritage in the Interreg Aurora area more visibility, using social innovations to transfer knowledge. ICH North will promote cross-border cooperation related to musical ICH and enhance the role of musical communities in the area, building bridges between institutions, educational institutions and heritage communities. Project partners are Centria University of Applied Sciences (FI), Novia University of Applied Sciences (FI), KulturÖsterbotten (FI), the Finnish Folk Music Institute (FI), Kulturens Bildningsverksamhet (SWE), Västernorrlands Museum (SWE) and The Arctic University of Norway UiT (NO). The project duration is 1.2.2023-31.12.2025.



Varvara Buzilă. Rhetoric of Dress: The Blouse with "Altiță" (Valorizing the Collections of the National Museum of Ethnography and Natural History and the Context of Cultural Realities). Chișinău: Lexon-Prim, 2022 (in Romanian and English). ISBN: 978-9975-163-16-3



The book has been recently published in the context of the inscription on the Representative List of the ICH of humanity "The Art of the Traditional Blouse with Embroidery on the Shoulder (altită) – an Element of Cultural Identity in Romania and the Republic of Moldova" (inscribed during 17.COM, on December 1, 2022). Varvara Buzilă, a renown ethnologist, highlights the development of this art and its main features, by analysing visual and documentary sources from the 19th and 20th centuries. A big part of the book is a museum catalogue of more than 100 traditional women blouses from the collections of the National Museum of Ethnography and Natural History (Chisinău, Republic of Moldova). The author analyzes the contemporary significance of this art, its bearers and admirers nowadays. The edition is addressed to readers willing to learn about the basic aspects of the traditional blouse, as well as to folk craftspeople who need such an edition in their activity of making traditional costumes.

Aral, Ahmet Erman. "Seeing the Glass Half-empty: Implications for Safeguarding Intangible Cultural Heritage through Formal Education in Türkiye." *International Journal of Heritage Studies*, 2022, Vol. 28 (11-12), 1286-1299

Formal education is a key element for safeguarding intangible cultural heritage in The UNESCO 2003 Convention, as reflected in Articles 2.2 and 14. However, integration of ICH into schools is challenging, due to problems in adapting the ICH Convention into national, regional and local contexts. This article critically examines Türkiye's experience in ICH safeguarding through formal education and some of its negative implications. The focus is on primary education Folk Culture course that was introduced after Türkiye ratified the Convention in 2006 and was attended by 206,570 students in the 2018–2019 academic year. Findings on curricula and interviews with teachers reveal that assignments of a particular unit to support the transmission of ICH is inefficient and misleading, since teachers were insufficiently involved in capacity-building activities. This article discusses the advantages and disadvantages of formal education and interprets it as a double-edged tool in the efforts towards ICH safeguarding. https://www.tandfonline.com/doi/full/10.1080/13527258.2022.2153264

Safeguarding intangible cultural heritage in Flanders: new publication on Flanders' policy vision and the report to UNESCO

In 2006 Belgium ratified the 2003 UNESCO Convention 2003. Intangible cultural heritage (ICH) forms part of the cultural policy of the Flemish Government, as in Belgium 'culture' is the responsibility of the different language communities. In 2010, the Flemish Government presented its very first policy visionon ICH. For more than a decade, it was an important reference text. With various developments both in Flanders and internationally, however, it was due for an update. With this in mind, in 2021-2022 the Flanders' Department of Culture, Youth and Media organised an update process during which various stakeholders were interviewed. This resulted in an updated policy vision, with challenges and ambitions for the next ten years. In parallel, the process of periodic reporting for UNESCO on the implementation of the 2003 Convention also ran through 2021. The Department of Culture, Youth and Media and NGO Workshop Intangible Heritage, the organisation for intangible heritage in Flanders, worked throughout the year 2021 on Flanders' input for this UNESCO report. The reporting process for UNESCO provided plenty of raw material for the renewed policy vision.



In this publication, you will find both the text of the policy Vision 2022 and a summary of the Flemish sub-report for the UNESCO Report 2021. Over the next decade, Flanders and many other partners are aiming to take new leaps in relation to living heritage: awareness raising, ICH in sustainable development and ICH and education are some of the areas for future actions. With the English translation of the online publication, Flanders wants to reach out to the international ICH community, hoping to inspire others, and also aiming at providing a basis for exchanging and sharing ideas on joint challenges the safeguarding of ICH. on https://publicaties.vlaanderen.be/view-file/52127
